

1879	<p>Herman Jan van Leeuwen</p> <p>Mr. H.J. van Leeuwen establishes his office in 's-Hertogenbosch. Until then, he worked in Eindhoven and formed a partnership with Mr. Pastoors.</p>			
1951 – 1962		<p>Harry Holla (1951)</p> <p>In 1951, Mr. H.B.S. Holla and Mr. L.W.M. Knitel established a partnership in 's-Hertogenbosch, where in 1965 Mr. M.P.C.A. Mol joined. The firm was named Holla, Knitel & Mol. The practice expanded, and in 1986 a merger took place with the 's-Hertogenbosch law firm of Mr. J.L. Brens et al.</p>	<p>Jurgens en Van Dooren (1955)</p> <p>In the fifties, Mr. R.B.M. van Dooren joined the office of Mr. A. Jurgens in Eindhoven. After the passing of Mr. Jurgens, Mr. Van Dooren became the namesake of the office. When Mr. Van Dooren passed away in 1987, his colleagues, including his son Mr. R.F.L.M. van Dooren, continued the practice.</p>	<p>Ginneken en Poelman (1962)</p> <p>In 1962, Mr. A.J.M. Poelman started a practice in Tilburg and shortly thereafter took over the practice of his former mentor, Mr. P.K. van Ginneken. This led to the partnership of Van Ginneken and Poelman. The collaboration then grew into the firm Poelman Denneman Bruinsma Advocaten, which now also has offices in Waalwijk and Eindhoven.</p>
1989	<p>Van Leeuwen Van der Eerden Advocaten</p> <p>About 110 years later, the office is led by the last lawyer descendant from the family, Mr. Cees van Leeuwen. The name had been changed to Van Leeuwen & Noordijk. In 1989, this firm merged with Van der Eerden & Van der Flier, forming Van Leeuwen Van der Eerden Advocaten.</p>	<p>Holla & Van Dooren</p> <p>A merger takes place between the 's-Hertogenbosch firm Holla, Knitel & Mol and the Eindhoven firm Van Dooren et al. This creates the law firm Holla & Van Dooren. In 1994, Mr. L.E.M. van Boxsel joins. Prior to that, Mr. Van Boxsel had a sixteen-year independent practice with a colleague.</p>		
1999	<p>Holla Poelman Advocaten</p> <p>Holla & Van Dooren merges with Poelman Denneman Bruinsma Advocaten. The name chosen for the merged firm is Holla Poelman Advocaten.</p>			
2007	<p>Holla Poelman van Leeuwen Advocaten</p> <p>The law firms Van Leeuwen Van der Eerden and Holla Poelman Advocaten merge and continue together under the overarching name Holla Poelman van Leeuwen Advocaten.</p>			
2009	<p>Holla Advocaten</p> <p>Because the name Holla Poelman van Leeuwen Advocaten is increasingly abbreviated to Holla in common parlance, it is decided to opt for a rebranding to choose the shorter and more recognizable name: Holla Advocaten.</p>			
2021 >	<p>Holla legal & tax</p> <p>In 2019, alongside its branches in 's-Hertogenbosch and Eindhoven, Holla Advocaten opens a third location in Utrecht. As the law firm increasingly focuses on the (inter)national market and adds expertise in tax law to its services, the name is changed in 2021 to Holla legal & tax.</p>
